Gather with other women to share our stories and learn more about caring for our woodlands. Join us for our fall adventure at Clark County's Levis/Trow Mound Recreational Area. This area begins the "Driftless" area in the state, featuring sandstone bluffs or mounds-one of the unique natural features. The area is managed to maintain and protect the natural environment and wildlife habitat of Levis/Trow Mound while providing recreational opportunities and a sustained supply of raw forest products.

We have reserved the warming Chalet for the day. Warm drinks and light snacks will be available about 8:45 am. We will be joined by Steve Meurett of the Neillsville Trails Association to learn more about the trails, history and geology of the area. He will then lead a short walk up the Mound. We will also learn about adverse possession or the occupation of land to which another person has title with the intention of possessing it as one's own. Weather permitting, we will take an informal hike on the Mound's interpretative trail to see what we can find or learn more about reading maps and using a compass.

Bring a water bottle and your walking stick. Wear hiking boots or sturdy shoes and dress in layers as we will spend some time inside and some outdoors.

A map is attached and a registration contact list will be sent out prior to the event, if you choose to carpool.

## Levis/Trow Mound Recreation Area

**N1589 Fischer Avenue**

**Neillsville, WI 54456**

Directions from the West (Merrillan): Take WI Hwy 95 East out of Merrillan for about 6 miles to Columbia Road/Fisher Avenue. Turn left or North onto Columbia Rd/Fisher Ave and travel 0.7 miles to the entrance of the Recreation Area on the left or West side of the road. Park by the Chalet.

Directions from the East (Neillsville): From WI Hwy 10 take WI Hwy 73 South (also S Grand Ave) for about 3 miles. When WI Hwy 73 intersects with WI Hwy 95 W, continue straight on WI Hwy 96 W for approximately 8.5 miles to Columbia Road/Fisher Ave. Turn right or North on Columbia Rd/Fisher Ave and travel 0.7 miles to the entrance of the Recreation Area on the left or West side of the road. Park by the Chalet.
