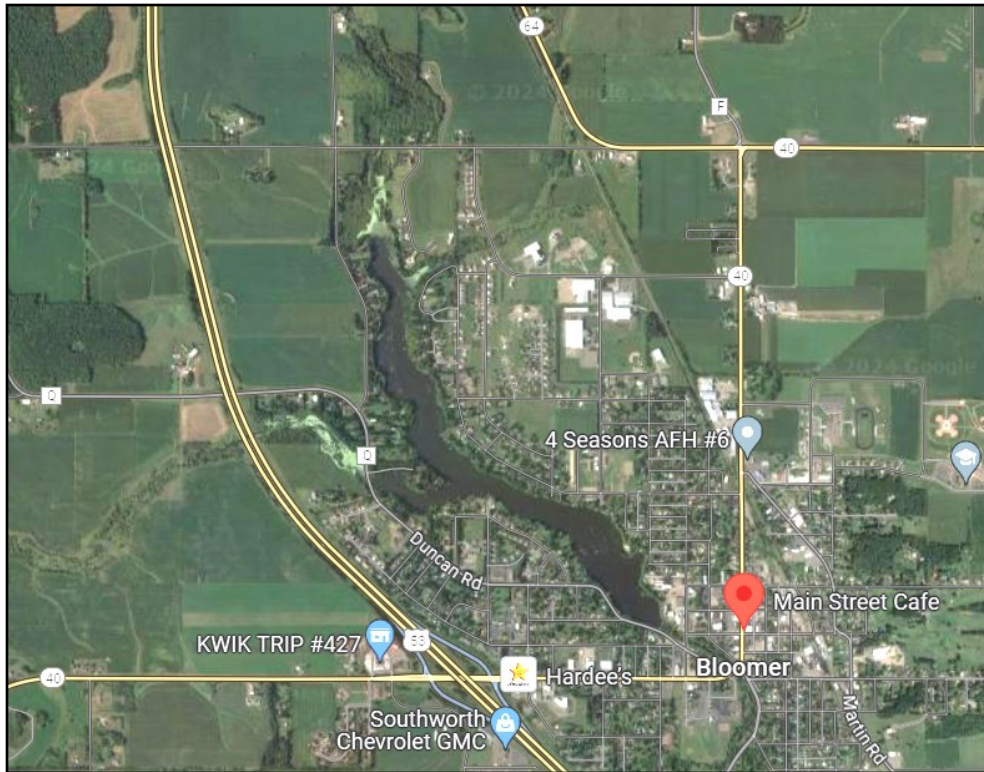

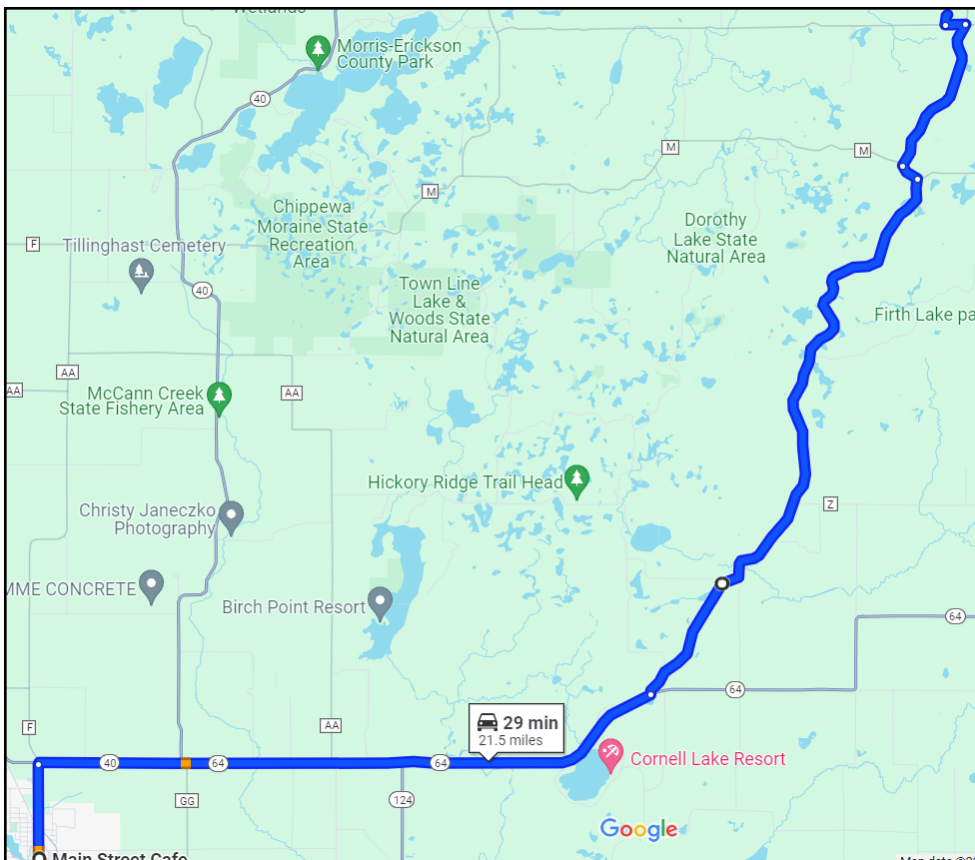
Main Street Café, 1418 Main St, Bloomer, WI 54724



Main Street Café is found on Main Street in Bloomer. Please note that WI Hwy 40 becomes 17th Street as it comes into Bloomer from the west and becomes Main Street when WI Hwy 40 turns north in downtown Bloomer.

There is parking behind the Café.

From Main St Café

Turn right (north) onto Main St in 1.3 miles make a right turn on Highway 64 in 8.5 miles take a left onto county highway E (north) in 8.8 miles turn left on county highway M (west) in 0.3 miles turn right onto county highway E (north) in 2.2 miles turn left onto 290th Ave (west)

Go by the first mailbox on the right and at the next set of 3 mailboxes turn into the farmer's driveway. Continue down the driveway staying left of the corn bins. Enter the two track driveway to our cabin—1/2 mile. Ample parking available.
